Sealed bids for the construction of Contract #1 – City Avenue and Pikeview Drive Sanitary Sewer and Stormwater Emergency Rehabilitation Project will be received, by the **Beckley Sanitary Board, Raleigh County, West Virginia until 2 p.m., L.P.T, on Friday, January 21, 2022**, at which time the Bids received will be publicly opened and read.

Received by the Beckley Sanitary Board

Envelope No.2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No.1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR – 1 of these contract documents. If such documents are found to be in order, Envelope No.2 “Bid Proposal”, will then be opened and will be publicly read

aloud. If the documents required to be contained in Envelope No.1 are not in order, Envelope No.2 will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Beckley Sanitary Board in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to bidders.

The Beckley Sanitary Board reserves the right to reject any and all bids.
