If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety-one (91) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Milton Municipal Utility Commission in an amount equal to five percent (5%) of the base bid.

<u>Nondiscrimination in Employment</u> - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.
