1 LS Mobilization/Demobilization; 1 LS WWTP Dewatering Upgrades including but not limited to: selective demolition of the existing sludge press building and polymer building, construction of a new sludge press building with plumbing, electrical, and HVAC system, installation of owner furnished belt filter press, owner furnished polymer system, and owner furnished conveyor system, new sludge pump, and all temporary sludge dewatering equipment required to maintain plant operation during construction. The work also includes all necessary controls, electrical, mechanical, site work, yard piping, and all other associated appurtenances for a complete operable system.

Bids shall be accompanied by a certified check or bid bond payable to Berkeley County Public Service Sewer District in an amount equal to five percent (5%) of the base bid.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.
