Bids for the construction of the Project will be received at **The Thrasher Group, Inc.** located at **160 Association Drive, Charleston WV 25311**, until **Thursday, March 24, 2022 at 2:00 p.m.** local time. At that time the Bids received will be **publicly** opened and read aloud through live stream. A link for the live-stream of the Bid Opening will be provided via Addendum.

The Project includes the following Work:

Selective demolition, ceramic tiling, wall covering, registration renovations, exterior façade upgrades and new exterior signage at the Roane County Family Health Care facility in Spencer, WV.

The Work will be substantially completed by July 15, 2022 and ready for final payment by July 31, 2022. Liquidated damages shall be \$1,000 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Roane County Family Health Care Renovations
Received by the Roane County Family Health Care

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Roane County Family Health in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

Roane County Family Health reserves the right to reject any and all bids.
