The Project includes the following Work:

Mobilization, clearing & grubbing, pavement removed, fence removed, removal misc. bleachers, excavation, embankment, geotextile fabric, aggregate base (as per plan), rock channel with protection (type C with filter), 18” conduit (type c), catch basin (No. 2-2B), placing stockpile topsoil, seeding & mulching, soil analysis test, repair seeding & mulching, inter-seeding, commercial fertilizer, lime, water, asphalt concrete surface course (type 1 (448)), and erosion control.
