Bids for the construction of the Project will be received at the **Downns Public Service District** located at **862 Huskey Highway, Suite 1, Fairmont, Marion County, WV 26554**, until **Thursday, June 16, 2022**, at **2:00 PM** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

1 LS Mobilization/Demobilization, 1 LS Videotaping of Project Area, 1 LS Erosion and Sediment Controls, 1,330 LF 6" C-900 CL150 DR 18 Water Line, 440 LF 6" HDPE DR-11 Water Line (Open Cut), 160 LF 6" HDPE DR-11 DIPS Water Line (Directional Drill), 2 EA HDPE Concrete Thrust Collars and Concrete Anchors, 1 EA 6" M.JT. Gate Valve w/ Box and Lid, 2 EA 6" Water Line Tie-In Complete including 6" Gate Valve, Two (2) 2" 45 degree M.JT. Fittings, 6"x2" Reducer, and 2" Dresser Coupling per each Tie-In, 1 EA 6" M.JT. A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Buffalo Creek Crossing
Received by the Downs Public Service District

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first, and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents

are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened, and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Downs Public Service District in an amount equal to five percent (5%) of the base bid.

Notice of Federal Wage Requirements – Contractors are required to comply with all laws pertaining to prevailing wage rates for the federal wages rates issued in accordance with the Davis Bacon Act.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Downs Public Service District reserves the right to reject any and all bids.
