The Town of Elizabeth (Owner) is requesting Bids for the construction of the following Project:

**Contract #1 – Enterprise Road and Henderson Run Road Waterline Extension**  
**Thrasher Project #10-10154**

Bids for the construction of the Project will be received at the **Elizabeth Wirt Volunteer Fire Department** located at **91 School View Street, Elizabeth, Wirt County, West Virginia 26143** until **Thursday, August 18, 2022 at 2:00 p.m.** local time. At that time, the Bids received will be publicly as applicable to the Project opened and read.

The Project includes the following Work:

Envelope No. 1 must have the following information presented on the front:

Bid on Contract – Contract #1 – Enterprise Road and Henderson Run Road Waterline Extension  
Received by the Town of Elizabeth

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to The Town of Elizabeth in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a current West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Town of Elizabeth reserves the right to reject any and all bids.
