The project will consist of providing upgrades to the intersection of Nickelplate St. and Main St. and will include pedestrian crosswalks with signals and push buttons, additional pedestrian connectivity, and traffic signal installation. In addition to the roadway improvements, all utilities in the project area will be replaced.
