**The replacement of existing water lines with 6" C900 conduit with hydrants, valves, and appurtenances on Maple Street, from Gauser Dr. east, approximately 2,400 LF.**

The Work will be substantially completed within **90** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **120** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$500.00** per day.
