Sealed bids for the construction of the project will be received at the **Village of Caldwell** located at the **Village Administrator's Office, 215 West Street, Caldwell, Ohio 43724, until Monday, March 6, 2023, at 5:00 pm local time.** At that time, the Bids received will be **publicly** opened and read in the Council Chambers.

The Project includes the following Work:

Installation of 11,253 LF of storm sewer various sizes, 860 LF of water line various sizes, 5,206 LF of 8" sanitary sewer, lining of 3,299 LF of existing sanitary sewer, 37,256 SY of pavement planning, and 1,552 CY of intermediate and 1,552 CY of surface course asphalt and related appurtenances.

Bids are requested for the following Contract: **AREA E, AREA G, AND INTERCEPTOR IMPROVEMENTS**

The Work will be substantially completed within **300** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **390** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$1,000.00** per day.

Bids shall be accompanied by a certified check or bid bond payable to the **Village of Caldwell** in an amount equal to ten percent (10%) of the base bid.

Contractor is required to comply with the Davis-Bacon Act for prevailing wage rates

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.
