General Notice

Midland Public Service District (Owner) is requesting Bids for the construction of the following Project:

Midland Public Service District Office and Shop Building Project
T10-11058

Bids for the construction of the Project will be received at the **Midland Public Service District** located at **127 Savory Street, Randolph County, Elkins, WV 26241**, until **Tuesday, February 14, 2023 at 2:00 pm** local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

All labor, materials, equipment, fees, insurance, bonds, taxes and similar contractor expenses as required for the construction of a one (1) story, 40'-0" x 30'-0" x 13'-0" office and 60'-0" x 80'-0" x 20'-0" shop, pre-engineered metal building, slab on grade structure with masonry veneer and siding, and metal roof. Work also includes all related plumbing, heating, and air conditioning, and electrical work, all site related work, and utilities.

Bids are requested for the following Contract: **Midland Public Service District Office and Shop Building Project.**

The Work will be substantially completed within 240 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 270 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Midland Public Service District Office and Shop Building Project
Received by the Midland Public Service District

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Midland Public Service District in an amount equal to five percent (5%) of the base bid.

Drug Free Workplace - West Virginia Code 21-1D-5 provides that any solicitation for a public improvement construction contract requires each vendor that submits a bid for the work to submit at the same time an affidavit of compliance with the bid. The enclosed drug-free workplace affidavit must be signed and submitted in the first envelope as evidence of the vendor's compliance with the provisions of Article 1D, Chapter 21 of the West Virginia code. Failure to submit the signed drug-free workplace affidavit in the first envelope shall result in disqualification of such bid.

DBE Requirements - Each Bidder must fully Comply with the Disadvantaged Business Enterprises, and Affirmative Action Requirements, as identified in the contract documents.

The Bidder agrees to make "positive efforts" to subcontract a portion of the total value of the contract to Disadvantaged Business Enterprises. This shall be done in compliance with the six (6) affirmative steps as outlined in 40 CFR 33.240. Failure to demonstrate positive efforts to do so may lead to rejection of bids. For this program, the term "subcontract" includes all construction, modification, and service work contracted for by the bidder in the execution of the work under this contract.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Midland Public Service District reserves the right to reject any and all bids.

Pre-bid Conference

A pre-bid conference for the Project will be held on **Tuesday, January 31, 2023 at 10:00 am at Midland Public Service District, 127 Savory Street, Randolph County, Elkins, WV 26241**. Attendance at the pre-bid conference is encouraged but not required.
