Bids for the construction of the Project will be received at the **Baltic Village Hall** located at **102 W Main St, Baltic, OH 43804** until **Thursday, February 9, 2023, at 11:00 AM** local time. At that time, the Bids received will be **publicly** opened and read.

The Project includes the following Work:

This project consists of approximately 1,126' of new asphalt pavement for Brickyard Road, beginning at the intersection with Ray Street (SR-93). Three drive aprons will be added to tie in with the existing storm sewer system.

Bids are requested for the following Contract: **BRICKYARD ROAD IMPROVEMENTS**

The Work will be substantially completed within **90** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **120** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$500.00** per day.
