TO WHOM IT MAY CONCERN:

A Pre-Bid Conference was held on Wednesday, May 3, 2023, on the above-referenced project, a copy of the sign in sheet is included in this Addendum. The following are clarifications and responses to questions posed by contractors for the above reference project.

A. <u>GENERAL</u>

1. THE BID OPENING DATE HAS BEEN CHANGED. BIDS WILL BE OPENED AT 11:00 A.M. AT THE CITY OF CLARKSBURG COUNCIL CHAMBERS ON MAY 18, 2023.

B. <u>SPECIFICATIONS</u>

None on this addendum.

C. DRAWINGS

1. Plan sheet #3 and 4 has been revised. Please use these new plan sheets when bidding this project.

D. **QUESTIONS AND RESPONSES**

1. QUESTION

Does the City of Clarksburg have a fill area where waste can be dumped from this project?

RESPONSE

The City of Clarksburg has a fill area that the contractor can use for soil and concrete. All trash including tires, metal pipe, electric poles and household garbage will need to disposed of by the contractor at the contractors expense.

2. QUESTION

Will the successful bidder have to be licensed by the City of Clarksburg?

RESPONSE

Yes. In order to bid the project, the contractor does not have to be licensed in Clarksburg, but the low bidder must have a valid license before beginning work.

3. QUESTION

Will the project require a permit from the City of Clarksburg?

RESPONSE

Yes, a permit will be required but The City of Clarksburg will waive the permit fee.

4. QUESTION

Will B&O taxes be charged to this project?

RESPONSE

Yes, a 2% B&O tax will be assessed to the successful bidder.

5. QUESTION

Will prevailing wage be required?

RESPONSE

No

6. QUESTION

Will the Engineer provide a cost estimate?

RESPONSE

An estimate was completed by the Engineer. However, The City of Clarksburg will not release the estimate to potential bidders.

7. QUESTION

Will access be provided from the storage units?

RESPONSE

Yes

8. QUESTION

How long is the construction contract and is the money to complete the project available now?

RESPONSE

The contractor will have 45 days to substantially complete the project with a final closeout of 60 days. Funds are available now. The Clarksburg Sanitary Board will consider the bids received at their meeting on June 9, 2023.

9. QUESTION

Can the contractor install a used piece of guard rail vs installing a new piece?

RESPONSE

Yes, as long as the guardrail is not rusted and looks similar to the existing guardrail that is in place now.

10. QUESTION

Are all necessary easements secured to complete the work?

RESPONSE

Easements are agreed upon by the property owners and shown on page #3 of the plans.

11. QUESTION

Can the gravel area at the end of the storage yard be used to stockpile materials?

RESPONSE

Yes. The contractor will be responsible for restoring the gravel area to its original condition after construction is complete. The contractor is encouraged to take pictures and videos to document the condition of the gravel before construction begins.

12. QUESTION

Can the contractor use the Brickside parking lot to access the site?

RESPONSE

Yes, the contractor will be responsible for restoring the asphalt parking lot to its original condition after construction is complete. The contractor is encouraged to take pictures and videos to document the condition of the parking lot before construction begins. Contractor will be responsible for fixing ruts or potholes created from heavy construction equipment.

13. QUESTION

There is a cable line attached to utility poles that have fallen over in the ditch. Will these lines be removed by the utility company?

RESPONSE

This line is dead and not active. Contractor will cut the line on both sides of the ditch and remove/dispose of the poles and wire.

14. QUESTION

There are several conduits and pipes that extend out into the ditch. Will these pipes be cut off by the contractor?

RESPONSE

Yes. The Contractor will cut the pipes 3-5 inches beyond the grouted surface.

15. QUESTION

Will the Contractor be required to install bypass pumping to keep water from eroding concrete grouting?

RESPONSE

The Contractor will be required to install the necessary diversions to allow the grouted ditch to dry before it is exposed to running water. The means and methods to install the diversions will be the contractor's responsibility.

16. QUESTION

How wide is the easement area? Will all the trees and brush need to be removed in that easement area?

RESPONSE

The easement area or LOD is shown on the revised plan sheet #3. The width varies. It is not our intention to clear all of the trees or brush in the easement area. Contractor will just remove the vegetation necessary to access the ditch.

17. QUESTION

Will the contractor be required to remove the sediment from the ditch at the bottom?

RESPONSE

Yes, the ditch is full of sediment and in order to install a grouted rock it must be cleaned out and reshaped.

18. QUESTION

The 54" pipe at the bottom is crushed along the sides. Will the contractor be required to fix this culvert?

RESPONSE

No, the contractor will be required to transition the grouted ditch to match the existing 54" culvert.
