E. CLARIFICATIONS


1. Once school is back in session, evening and weekend hours will be required.

5. Salvage existing signage and door numbers to be reinstalled on new doors.

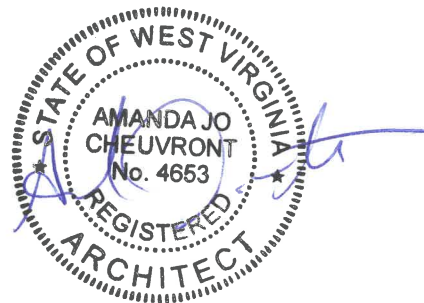
