The Project includes the following Work:

Construction of approximately 2000 LF of Taxiway including erosion and sediment controls, removal of existing pavement, windcone and storm pipe, 20,000 cy of unclassified excavation, 4,500 cy of crushed aggregate base course, 2,200 TN of HMA base course, 2,400 TN of HMA wearing course, 12 Type G Inlets, 2,400 LF of 36" HDPE, 130 New LED MITL, L-861T on Existing Base Cans and 33 New LED MITL on New Base Cans, 15,400 LF of No. 8 AWG, 5kV, L-824 Type C Cable and 5,500 LF of No. 6 AWG, Solid bare copper counterpoise wire and 5400 LF of non-encased electrical conduit 2".
