Bids for the construction of the Project will be received at the City of Bridgeport located at **515 W. Main Street, Bridgeport, Harrison County, WV 26330** until **Thursday, August 17, 2023,** at **10:00 AM** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

Removal and Replacement of existing 8" ACP and PVC gravity sewer and manholes with new 12" PVC gravity sewer and poly-lined manholes, installation of new 12" PVC gravity sewer, installation of new 12" HDPE gravity sewer at variable grade, lining of one (1) existing well at the lift station, tying-in existing lateral sewer connections, two (2) bore and jack road crossings, and restoration of all disturbed areas.

Bids are requested for the following Contract: Lift Station #9 Gravity Sewer

The Work will be substantially completed within 90 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 120 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the City of Bridgeport in an amount equal to five percent (5%) of the base bid.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.
