Sealed bids for the construction of the Project will be received at the City of Toronto, Ohio located at **416 Clark Street, Toronto, OH 43964** until **Thursday, September 7, 2023, at 1:30 pm** local time. At that time, the Bids received will be **publicly** opened and read in the **Council Chambers**.

The Project includes the following Work:

This project will consist of approximately 1,643.34' of new asphalt roadway with curb and gutter driveway approaches to extend the existing Mara Road to Titanium Way Road. Four (4) parking spaces and a curb ramp have been provided for future use with a bike path. Pavement overlay for existing Mara and Nebo Roads. All utilities and most grading were performed in Phase 1.

Bids are requested for the following Contract: **CONTRACT 2 - MARA ROAD EXTENSION**

The Work will be substantially completed within **60** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **90** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$1,000.00** per day.
