**a.** The project is to complete a partially installed fire sprinkler system. Portions of the system have been installed; however, it is the contractor's responsibility to review the partial system installed, and complete the system to provide a fully functional Fire sprinkler system. Components installed shall match the manufacturer and materials of the components currently installed. The contractor shall be responsible for providing a complete design from a licensed Sprinkler Designer.

Bids not received by 2:00 p.m. on January 17, 2024, will not be accepted, no exceptions.

Liquidated Damages are set at **\$250**/Per Day.
