General Notice

Greenbrier Public Service District #2 (Owner) is requesting Bids for the construction of the following Project:

Sanitary Sewer System Improvements Project 020-01455

Bids for the construction of the Project will be received at the **Greenbrier Public Service District #2** located at **222 Bill Johnson Drive, Rainelle, Greenbrier County, West Virginia**, until **Wednesday, August 14, 2024**, at **2:00 p.m.** local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Contract #1 - Marfrance Sanitary Sewer Rehabilitation

Removal and replacement of 20,065 LF of gravity sewer mains, 50 manholes, and all necessary appurtenances, spray lining of an additional 45 existing manholes, and all other work necessary for the rehabilitation of wastewater collection infrastructure in the community of Marfrance, WV.

Contract #2 – Quinwood Sanitary Sewer Rehabilitation

Removal and replacement of approximately 18,650 LF of gravity sewer mains, 60 manholes, and all necessary appurtenances, spray lining of an additional 40 existing manholes, installation of approximately 3,300 LF of 6" forcemain, and all other work necessary for the rehabilitation of wastewater collection infrastructure in the community of Quinwood, WV.

Contract #3 – Crichton Sanitary Sewer Rehabilitation

Removal and replacement of approximately 17,800 LF of gravity sewer mains, 52 manholes, and all other necessary appurtenances, spray lining of an additional 48 existing manholes, and all other work necessary for the rehabilitation of wastewater collection infrastructure in the community of Crichton, WV.

Contract #4 -Lift Station Rehabilitation

Upgrades to eight (8) existing wastewater lift stations, decommissioning of two (2) existing wastewater pump stations, construction of one (1) new duplex submersible lift station including a concrete wet well and valve vault, pumps, valves, piping, electrical controls, and emergency generator.

Contract #5 – Wastewater Treatment Plant Upgrade

Upgrades to the Wastewater Treatment Plant including upgrades to the influent pump station, oxidation ditch, clarifiers, chlorine contact chamber, sludge drying beds, and lab building, as well as the construction and installation of a new headworks structure and equipment, including automatic bar screening and grit removal system, a new chlorine building, and a new automatic fence gate.

Contract #6 – Work Truck (Vendor Bid)

Furnish and deliver two (2) work trucks with all necessary appurtenances as indicated in the specifications.

Contract #7 – Wastewater Pumps (Vendor Bid)

Furnish and deliver nine (9) sets of wastewater pumps with guide rails, intermediate brackets, bases, and all necessary appurtenances as indicated in the specifications.

Contract #8 – Vac Truck (Vendor Bid)

Furnish and deliver one (1) vac truck with all necessary appurtenances as indicated in the specifications.

Contract #9 – Crane Truck (Vendor Bid)

Furnish and deliver one (1) crane truck with all necessary appurtenances as indicated in the specifications.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

"DBE REQUIREMENTS"

Each Bidder must fully comply with the requirements, terms, and conditions as set forth in the contract documents to achieve Disadvantaged Business Enterprise (DBE) participation during the performance of this contract. The bidder commits itself to the program for DBE participation and all other requirements, terms, and conditions of the bid conditions by submitting a properly signed bid.

The bidder agrees to make "good faith efforts" to sub-contract a portion of the total value of the contract to disadvantaged businesses. This shall be done in compliance with the six (6) affirmative steps as outlined in 40 CFR 31.36(e). Failure to demonstrate positive efforts to do so may lead to rejection of bids. For the purpose of this program, the term "subcontractor" includes all construction, modification, and service work contracted for by the bidder in the execution of the work under this contract.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Greenbrier Public Service District #2 in an amount equal to five percent (5%) of the base bid.

<u>Nondiscrimination in Employment</u> - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

<u>Notice of Federal Wage Requirements</u> – Contractors are required to comply with all laws pertaining to federal wage rates as issued in accordance with the Davis Bacon act. The contractor will be required to pay the federal wage rates appropriate for each worker classification.

<u>Drug Free Workplace</u> - West Virginia Code 21-1D-5 provides that any solicitation for a public improvement construction contract requires each vendor that submits a bid for the work to submit at the same time an affidavit of compliance with the bid. The enclosed drug-free workplace affidavit must be signed and submitted in the first envelope as evidence of the vendor's compliance with the provisions of Article 1D, Chapter 21 of the West Virginia code. Failure to submit the signed drug-free workplace affidavit in the first envelope shall result in disqualification of such bid.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Greenbrier Public Service District #2 reserves the right to reject any and all bids.
