**Town of West Hamlin** (Owner) is requesting Bids for the construction of the following Project:

**Pre-Sedimentation Basin Replacement Project**  
**T10-11153**

Bids for the construction of the Project will be received at the **West Hamlin Town Hall** located at **6649 Guyan Street**, West Hamlin, WV 25571 until **Wednesday, November 13, 2024**, at **10:00 a.m.** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

Demolition and removal of an existing pre-sedimentation basin, including concrete foundation, walkways, inlet and outlet piping, and hauling sediment buildup off-site. Installation of a new 150,000-gallon pre-sedimentation basin with a spiral baffle and weir system, concrete foundation, sediment removal piping and valves, inlet, outlet, and overflow piping, and all other necessary appurtenances for a complete and operational system.

Bids are requested for the following Contract: **Pre-Sedimentation Basin Replacement /T10-11153**

The Work will be substantially completed within **270** calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within **300** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$1,500** per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder  
Bid on Contract – Pre-Sedimentation Basin Replacement Project  
Received by the Town of West Hamlin

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Town of West Hamlin in an amount equal to five percent (5%) of the base bid.

Suspension and Debarment – Recipient shall not entertain the use of businesses that are listed on the “System for Award Management” (SAM) at [www.Sam.gov](http://www.Sam.gov) in accordance with 2 CFR Part 1532 and Subpart B and C of 2 CFR Part 180.

Drug Free Workplace - West Virginia Code 21-1D-5 provides that any solicitation for a public improvement construction contract requires each vendor that submits a bid for the work to submit at the same time an affidavit of compliance with the bid. The enclosed drug-free workplace affidavit must be signed and submitted in the first envelope as evidence of the vendor’s compliance with the provisions of Article 1D, Chapter 21 of the West Virginia code. Failure to submit the signed drug-free workplace affidavit in the first envelope shall result in disqualification of such bid.

DBE Requirements - Each Bidder must fully Comply with the Disadvantaged Business Enterprises, and Affirmative Action Requirements, as identified in the contract documents.

The Bidder agrees to make “positive efforts” to subcontract a portion of the total value of the contract to Disadvantaged Business Enterprises. This shall be done in compliance with the six (6) affirmative steps as outlined in 40 CFR 33.240. Failure to demonstrate positive efforts to do so may lead to rejection of bids. For this program, the term “subcontract” includes all construction, modification, and service work contracted for by the bidder in the execution of the work under this contract.

All Bidders are required to have a West Virginia Contractor’s License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Town of West Hamlin reserves the right to reject any and all bids.

### **Pre-bid Conference**

A mandatory pre-bid conference for the Project will be held on **Friday, October 18, 2024, at 10:00 a.m.** at **West Hamlin Town Hall, 6649 Guyan Street, West Hamlin, WV 25571**. Bids will not be accepted from Bidders that do not attend the mandatory pre-bid conference. There will also be a Microsoft Teams virtual option for this Mandatory Pre-Bid conference. If a Contractor is unable to attend this Mandatory Pre-Bid Meeting in person, attending the meeting virtually will be acceptable.
