**Mingo County Public Service District** (Owner) is requesting Bids for the construction of the following Project:

**Sanitary Sewer Collection System Improvements**

Bids for the construction of the Project will be received at the **Mingo County Public Service District** located at **1 Riverside Drive, Naugatuck, Mingo County, West Virginia 25685** until **Tuesday, October 8, 2024 at 2:00 pm** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

**Contract #1:**

The project consists of approximately 325 LF of 8” PVC gravity sewer line, removing and replacing 1,450 LF of 8” PVC gravity sewer line, 230 LF of DIP gravity sewer line, 440 LF of 4” PVC service lateral, 225 LF of 16” bore and jack steel casing, 4,275 LF of 8” PVC gravity sewer pipe lining, 3 manholes, one doghouse manhole, one flat top manhole, removing and replacing 13 manholes, rehabilitating 18 manholes, 20 VF of manhole riser pipe, reconnecting 125 existing customer service laterals, pump station rehabilitation, 15 LF of 12” steel storm pipe, surface restoration, and all other appurtenances for a complete and operational project.

**Contract #2:**

This project consists of approximately 5,650 LF 8” PVC SDR-35 Gravity Sewer Line; 500 LF 16” Steel Casing (Bore & Jack); 500 LF 8” Steel Casing (Bore & Jack); 40 EA 48” Dia. Manhole Base, Cone Top, Regular Casting; 50 VF 48” Dia. Manhole Riser Section; 40 EA 8”x4” PVC Wye Connection; 300 LF 4” PVC Service Lateral Pipe; 500 LF 4” PVC Service Lateral Pipe (Bore and Jack); 40 EA Customer Service Lateral Cleanout; surface restoration, and all other appurtenances for a complete and operational project..

**Contract #3:**

Tis project consists of approximately 5,300 LF 8” PVC SDR-35 Gravity Sewer Line; 825 LF 6” PVC SDR-35 Gravity Sewer Line; 125 LF 4” HDPE DR-9 Forcemain (Directional Drill); 500 LF 16” Steel Casing (Bore & Jack); 75 LF 12” Steel Casing (Bore & Jack); 40 EA 48” Dia. Manhole Base, Cone Top, Regular Casing; 40 VF 48” Dia. Manhole Riser Section; 15 EA 8”x4” PVC Wye Connection; 10 EA 6”x4” PVC Wye Connection; 325 LF 4” PVC SDR-35 Service Lateral Pipe; 5 EA 6” Gravity Terminal Line Cleanout; 25 EA Customer Service Lateral Cleanout; 1 LS Lonesome Valley Lift Station, Surface restoration and all other appurtenances for a complete and operational project..

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Mingo County Public Service District in an amount equal to five percent (5%) of the base bid.

Suspension and Debarment – Recipient shall not entertain the use of businesses that are listed on the “System for Award Management” (SAM) at [www.Sam.gov](http://www.Sam.gov) in accordance with 2 CFR Part 1532 and Subpart B and C of 2 CFR Part 180.

Nondiscrimination in Employment - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

American Iron and Steel Requirement – P.L. 113-76 Consolidated Appropriations Act, 2014 (ACT), includes an “American Iron and Steel” (AIS) requirement in section 436 that requires Clean Water State Revolving Loan Fund (CWSRF) and Drinking Water Revolving Loan Fund (DWSRF) assistance recipients

to use iron and steel products that are produced in the United States for projects for the construction, alteration, maintenance, or repair of a public water system or treatment works.

Notice of Federal Wage Requirements – Contractors are required to comply with all laws pertaining to federal wage rates as issued in accordance with the Davis Bacon Act. The contractor will be required to pay the federal wage rates appropriate for each worker classification.

Drug Free Workplace - West Virginia Code 21-1D-5 provides that any solicitation for a public improvement construction contract requires each vendor that submits a bid for the work to submit at the same time an affidavit of compliance with the bid. The enclosed drug-free workplace affidavit must be signed and submitted in the first envelope as evidence of the vendor's compliance with the provisions of Article 1D, Chapter 21 of the West Virginia code. Failure to submit the signed drug-free workplace affidavit in the first envelope shall result in disqualification of such bid.

Prospective Bidders should note that this Contract will include the following critical requirements as identified in the Contract Documents.

1. Affirmative Action Program Requirements and Goals
2. Certificate of Non-Segregated Facilities
3. Specific Labor Standard Provisions
4. WV Contract Licensing Act – All bidders are required to have a WV Contractor's License per Section 30-42-12 of the WV Code.
5. American Iron and Steel Requirement – P.L. 113-76, Section 436.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Federal Aid Contract Requirements -- This project is funded in part with funds made available from the Federal Government through the US Army Corps of Engineers Section 340 program. The successful bidder shall comply with all applicable Federal and State laws and regulations for construction projects receiving Federal aid, including, but not limited to: Section 601 of the Civil Rights Act of 1964, Public Law 88-352 (42 U.S.C. 2000d) and Department of Defense Directive 5500.11 issued pursuant thereto; Army Regulation 600-7, entitled "Nondiscrimination on the Basis of Handicap in Programs and Activities Assisted or Conducted by the Department of the Army"; and all applicable Federal labor standards requirements including, but not limited to, 40 U.S.C. 3141-3148 and 40 U.S.C. 37013708 (revising, codifying and enacting without substantive change the provisions of the Davis Bacon Act (formerly 40 U.S.C. 276a et seq.), the Contract Work Hours and Safety Standards Act (formerly 40 U.S.C. 327 et seq.) and the Copeland Anti-Kickback Act (formerly 40 U.S.C. 276c)). The successful bidder shall also comply with Presidential Executive Orders 11246 and 11375."

Any contract or contracts awarded under this invitation for bids are expected to be funded in part by grants and loans from: the West Virginia Department of Environmental Protection State Revolving Fund. Neither the United States, the State of West Virginia nor any of their departments, agencies or employees are or will be a party to this invitation to bid or any resulting contract.

Every ARC grant, subgrant, and cooperative agreement must comply with governmentwide grant regulations at Title 2 of the Code of Federal Regulations (CFR), Part 200 ("2 CFR Part 200"). These regulations address administrative requirements, cost principles, and audit requirements for federal awards. They provide guidance for pre-award and post-award requirements in areas such as record retention, procurement, subaward management, and performance measures.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders. Bids received by Contractors that did not attend the Mandatory Pre-Bid Conference will be returned unopened to the Bidders.

The Mingo County Public Service District reserves the right to reject any and all bids.
