Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Acquisition of Snow Removal Equipment – Broom with Airblast per the specifications.

The Work will be substantially completed within 300 days after the date when the Contract Times commence to run and completed and ready for final payment within 330 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500 per day.

If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened, and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Wood County Airport Authority reserves the right to reject any and all Bids.
