**Berkeley County Public Service Sewer District** (Owner) is requesting Bids for the construction of the following Project:

Task Order #1 – Northwinds – Potomac Park WWTP Decommissioning 020-10145

Bids for the construction of the Project will be received at the Berkeley County Public Service Sewer District located at 65 District Way, Martinsburg, WV 25402, until Friday, November 22, 2024, at 11:00 AM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

The installation of approximately 10,000 LF of gravity sewer pipe, 7,500 LF of forcemain, two (2) pump stations-complete, one (1) pump station upgrade-complete, the demolition of the existing wastewater treatment plant at the Northwinds housing development, and all necessary related appurtenances.

Bids are requested for the following Contract: **Task Order #1 – Northwinds – Potomac Park WWTP Decommissioning.** 

The Work will be substantially completed within 330 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 360 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder Bid on Contract – Task Order #1 – Northwinds – Potomac Park WWTP Decommissioning Received by the Berkeley County Public Service Sewer District

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Berkeley County Public Service Sewer District in an amount equal to five percent (5%) of the base bid.

<u>Suspension and Debarment</u> – Recipient shall not entertain the use of businesses that are listed on the "System for Award Management" (SAM) at <u>www.Sam.gov</u> in accordance with 2 CFR Part 1532 and Subpart B and C of 2 CFR Part 180.

<u>Drug Free Workplace</u> - West Virginia Code 21-1D-5 provides that any solicitation for a public improvement construction contract requires each vendor that submits a bid for the work to submit at the same time an affidavit of compliance with the bid. The enclosed drug-free workplace affidavit must be signed and submitted in the first envelope as evidence of the vendor's compliance with the provisions of Article 1D, Chapter 21 of the West Virginia code. Failure to submit the signed drug-free workplace affidavit in the first envelope shall result in disqualification of such bid.

<u>DBE Requirements</u> - Each Bidder must fully Comply with the Disadvantaged Business Enterprises, and Affirmative Action Requirements, as identified in the contract documents.

The Bidder agrees to make "positive efforts" to subcontract a portion of the total value of the contract to Disadvantaged Business Enterprises. This shall be done in compliance with the six (6) affirmative steps as outlined in 40 CFR 33.240. Failure to demonstrate positive efforts to do so may lead to rejection of bids. For this program, the term "subcontract" includes all construction, modification, and service work contracted for by the bidder in the execution of the work under this contract.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Berkeley County Public Service Sewer District reserves the right to reject any and all bids.
