At that time the Bids received will be **publicly** opened and read.

Furnish and deliver one (1) compact track loader and attachments, and one (1) compact excavator and attachments with all necessary appurtenances as indicated in the specifications.

Furnish and deliver one (1) utility truck and two (2) service trucks with all necessary appurtenances as indicated in the specifications.
