Mason County Development Authority (Owner) is requesting Bids for the construction of the following Project:

Structure Demolition (Package 3)

Bids for the construction of the Project will be received at the **Mason County Development Authority Office** located at **305 Main Street, Point Pleasant, WV 25550** until **Tuesday April 15th, 2025, at 1:00** local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Demolition of structures located within the former Town of Henderson at the following addresses:

505 Holloway Street, 508 Holloway Street, 406 Henderson Street, 404 Holloway Street, 304 Henderson Street, 507 Henderson Street, 42 Forrest Street, 403 Chestnut Street, 203 Smith Street, 507 Holloway Street, 207 Smith Street, 207 Chestnut Street, and 407 Chestnut Street.

The Work will be substantially completed within **60** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **75** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$500** per day.

A two-envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Structure Demolition (Package 3)
Received by the Mason County Development Authority

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Bids shall be accompanied by a certified check or bid bond payable to Mason County Development Authority in an amount equal to five percent (5%) of the base bid.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Mason County Development Authority reserves the right to reject any and all bids.

A pre-bid conference for the Project will be held on **Wednesday April 9th at 10:30 AM** onsite at **403 Chestnut Street, Henderson, 25106 WV**. Attendance at the pre-bid conference is encouraged but not required.
