The **Village of Scio** (Owner) is requesting Bids for the construction of the following Project:

**HILLTOP ST. & MAIN ST. SANITARY SEWER EXTENSION**  
**THRASHER PROJECT #T20-11019**

Bids for the construction of the Project will be received at the **Village of Scio** located at **210 East Main Street, Scio, Ohio, 43988**, until **Wednesday, July 16, 2025**, at **1:00 PM** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

**The proposed project is installation of 1,850 LF of 8" PVC sanitary sewer line with approximately 24 laterals. The road on Hilltop Dr. will have full-width pavement for approximately 155 CY. Where the sanitary sewer line is in Main Street, the line will be in the sidewalk, and approximately 16 CY of concrete will be put back in place of existing sidewalk.**

Bids are requested for the following Contract: **HILLTOP ST. & MAIN ST. SANITARY SEWER EXTENSION**

The Work will be substantially completed within **150** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **180** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$1,500.00** per day.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the **Village of Scio** in an amount equal to five percent (5%) of the base bid.

This procurement is subject to the EPA Policy of encouraging the participation of small business in rural areas (SBRAs).

Suspension and Debarment – Recipient shall not entertain the use of businesses that are listed on the “System for Award Management” (SAM) at [www.Sam.gov](http://www.Sam.gov) in accordance with 2 CFR Part 1532 and Subpart B and C of 2 CFR Part 180.

DBE Requirements – Each Bidder must fully Comply with the Disadvantaged Business Enterprises, and Affirmative Action Requirements, as identified in the contract documents.

Build America, Buy America Requirements – Build America, Buy America (BABA) is required, as identified in the contract documents.

Notice of Federal Wage Requirements – Contractors are required to comply with all laws pertaining to federal wage rates as issued in accordance with the Davis Bacon act. The contractor will be required to pay the federal wage rates appropriate for each worker classification.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The **Village of Scio** reserves the right to reject any and all bids.
