

## ADVERTISEMENT FOR BIDS

### HATFIELD MCCOY REGIONAL RECREATION AUTHORITY LOGAN COUNTY, WEST VIRGINIA RISING ESTATES – PHASE I

#### General Notice

Hatfield McCoy Regional Recreation Authority (Owner) is requesting Bids for the construction of the following Project:

#### Rising Estates – Phase I T30-11191

Bids for the construction of the Project will be received at the **Hatfield McCoy Regional Recreation Authority Office** located at **180 East Appalachian Outpost Trail, Man, WV 25632**, until Tuesday, **March 31<sup>st</sup>, 2026 at 2:00 pm** local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Installation of fabric, stone, and asphalt on approximately 3,000 linear feet of existing access road, approximately 1,600 linear feet of guardrail, installation of a water booster station and 1,560 linear feet of 6" waterline, installation of approximately 2,500 linear feet of 2" Gas line, 1,800 linear feet of 4" SCH 40 and 2" SCH 40 conduit, approximately 2,000 cy of earthwork to prepare a pad for future cabins, utility connections at each cabin location, installation of fabric and stone on approximately 4,200 linear feet of existing trail and related appurtenances.

Bids are requested for the following Contract: **Rising Estates – Phase I**

The Work will be substantially completed within 150 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 180 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder  
Bid on Contract – Rising Estates – Phase I  
Received by the Hatfield McCoy Regional Recreation Authority

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the Hatfield McCoy Regional Recreation Authority in an amount equal to five percent (5%) of the base bid.

DBE Requirements - Each Bidder must fully Comply with the Disadvantaged Business Enterprises, and Affirmative Action Requirements, as identified in the contract documents.

The Bidder agrees to make “positive efforts” to subcontract a portion of the total value of the contract to Disadvantaged Business Enterprises. This shall be done in compliance with the six (6) affirmative steps as outlined in 40 CFR 33.240. Failure to demonstrate positive efforts to do so may lead to rejection of bids. For this program, the term “subcontract” includes all construction, modification, and service work contracted for by the bidder in the execution of the work under this contract.

Nondiscrimination in Employment – Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

Suspension and Debarment – Recipient shall not entertain the use of businesses that are listed on the “System for Award Management” (SAM) at [www.Sam.gov](http://www.Sam.gov) in accordance with 2 CFR Part 1532 and Subpart B and C of 2 CFR Part 180.

Prospective Bidders should note that this Contract will include the following critical requirements as identified in the Contract Documents.

1. Affirmative Action Program Requirements and Goals
2. Certificate of Non-Segregated Facilities
3. Specific Labor Standard Provisions
4. WV Contract Licensing Act – All bidders are required to have a WV Contractor’s License per Section 30-42-12 of the WV Code.
5. WV Alcohol and Drug Free Workplace Act
6. Executive Order No. 10925, Build America, Buy America
7. Any other requirements deemed critical.

Build America, Buy America – This project is subject to the Build America, Buy America Act (BABAA) requirements under Title IX of the Infrastructure Investment and Jobs Act (IIJA), Pub. L. 117-58, §§ 70901-70953. Absent an approved waiver, all iron, steel, manufactured products, and construction materials used in this project must be produced in the United States.

Drug Free Workplace – West Virginia Code 21-1D-5 provides that any solicitation for a public improvement construction contract requires each vendor that submits a bid for the work to submit at the same time an affidavit of compliance with the bid. The enclosed drug-free workplace affidavit must be signed and submitted in the first envelope as evidence of the vendor’s compliance with the provisions of Article 1D, Chapter 21 of the West Virginia code. Failure to submit the signed drug-free workplace affidavit in the first envelope shall result in disqualification of such bid.

Prospective Bidders are advised that the contracts awarded under this bid are to be funded in whole or in part by Hatfield McCoy Regional Recreation Authority and the West Virginia Department of Environmental Protection - Office of Abandoned Mine Lands Economic Revitalization (AMLER) Program.

All Bidders are required to have a West Virginia Contractor's License per Section §30-42-12 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders. Bids received by Contractors that did not attend the Mandatory Pre-Bid Conference will be returned unopened to the Bidders.

The Hatfield McCoy Regional Recreation Authority reserves the right to reject any and all bids.

### **Pre-bid Conference**

A mandatory pre-bid conference for the Project will be held on **Tuesday, March 17<sup>th</sup>, 2026 at 10:00 am** at **Hatfield McCoy Regional Recreation Authority Office, 180 East Appalachian Outpost Trail, Man, WV 25632**. Bids will not be accepted from Bidders that do not attend the mandatory pre-bid conference.
